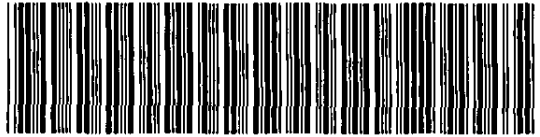

ARTICLES OF AMENDMENT

Changing the Corporate Name to Rainbow Housing Corporation

ST. AGNES HOUSING CORPORATION

(A Florida Not for Profit Corporation)

Pursuant to the provisions of sections 617.1002 and 617.1006, Florida Statutes, the undersigned Florida nonprofit corporation adopts the following articles of amendment to its articles of incorporation.

Adoption of Amendment:

- A. There are no members entitled to vote on the amendment.
- B. These Articles of Amendment were adopted by the board of directors of this Corporation at a regular meeting with a quorum being present which was held on JUNE 21, , 2013. This board meeting met the requirements of both the Articles of Incorporation and the bylaws.
