ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF RAINBOW HOUSING CORPORATION

Pursuant to the provisions of Section 617.1006, Florida Statutes, this Florida Not For Profit Corporation adopts the following amendments to its Articles of Incorporation:

Amendment

The paragraph of the Corporation's Articles of Incorporation called "CORPORATE PURPOSES" is deleted in its entirety and the following substituted therefor:

CORPORATE PURPOSES

The Corporation shall be a not for profit corporation under the Florida Not for Profit Corporation Act and is irrevocably dedicated to and operated exclusively for non-profit purposes. The purposes for which the Corporation is organized are exclusively charitable within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as amended (or any successor thereto) including but not limited to, the building of workforce, senior citizen and affordable housing to low and moderate income families. The Corporation, in connection with furthering its purposes, shall be permitted to engage, either directly or through ownership of interests in entities, in the acquisition, development, construction, management, and leasing of all types of residential housing to provide such Furthermore, this corporation may engage only in activities permitted under the laws of the State of Florida and the United States of America as shall constitute activities in furtherance of such exempt purposes. In furtherance of its exempt purposes, the corporation may promote, establish, conduct and maintain activities on its own behalf and it may contribute to or otherwise assist other corporations, organizations and institutions carrying on exempt activities.

Adoption of Amendment

There are no members or members entitled to vote on the amendment. In accordance with the Corporation's Bylaws, the Corporation's Board of Directors adopted the amendment on March 14, 2019.
