The undersigned for the purpose of forming a not for profit corporation under the Florida Not for Profit Act (Florida Statute 617.1007), and hereby adopts the following Articles of Incorporation.

ARTICLE I

Name

The name of this corporation is CONGREGATION TEHILLAT HASHEM, INC.

ARTICLE II

Principal Place of Business and Mailing Address

The principal address and mailing address is 1970 N.W. 178th Terrace, Pembroke Pines, Florida 33029.

ARTICLE III

Duration

This Corporation shall have perpetual existence commencing upon the filing of these Articles of Incorporation.

ARTICLE IV

PURPOSE

The specific purpose for which the corporation is organized is to be an organization organized for religious purposes. The Corporation is to be qualified as a not for profit Corporation in conformity with section 501 (c) (3) of the Internal Revenue Code as amended or similar provision in a future code from the Internal Revenue Service. No dividend is to be paid by the Corporation to a member director and no profit of the corporation shall inure to a member or director of the Corporation.

ARTICLE V

Termination

Upon the dissolution of the Corporation, assets shall be distributed for one or more exempt purposes within the meaning of Section 501 (c) of the Internal Revenue Code of 1986, as amended or the corresponding provision of any future United States Internal Revenue Code, or shall be distributed to the Federal Government, or to a state or local government for a public purpose, as determined by the last Board of Directors of the Corporation.

ARTICLE VI

BOARD OF DIRECTORS

The Board of Directors may increase or decrease the number of directors of accordance with the Corporation's Bylaws, however, the Board of Directors shall consist of a minimum of three persons who qualify as directors under Florida Statutes.

**ARTICLE VII
Members**

The Corporation will have members. The bylaws of the Corporation contain provisions relating to qualification for membership, the rights of members, and other such matters.




