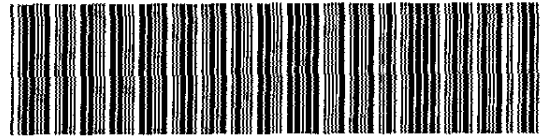

Of

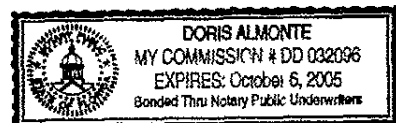
