The Articles are amended as follows:

Remove all of the below language in Article III, Paragraph A.

TALLAH.

The purposes for which the corporation is organized shall be to protect the environment, character and biodiversity of the Gulf Coast's bays, beaches a

The purposes for which the corporation is organized shall be to protect the environment, character and biodiversity of the Gulf Coast's bays, beaches and barrier islands, by acquiring and holding real property, conservation easements and nature preserves, and to provide education and training for responsible stewardship. 'Character' shall include historical resources, such as working waterfronts and marinas for the purposes of sports fishing, recreation, exhibitions educating the public about Florida's traditional working waterfronts, or the commercial harvest of marine organisms by state-licensed fishermen on waterfront parcels.

Replace the language in Article III, Paragraph A with the following:

The purposes for which the corporation is organized shall be to protect the land and water in Southwest Florida for the benefit of people and nature. We envision a future where the human and natural worlds of Southwest Florida flourish together.
