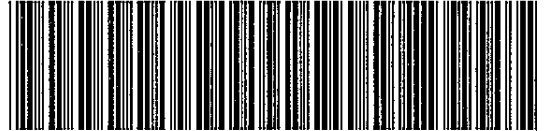

Articles of Incorporation of the undersigned, a majority of whom are citizens of the United States, desiring to form a Non-Profit Corporation under the Non-Profit Corporation Law FLORIDA, do hereby certify:

Article 1: The name of the corporation shall be: SANS PAREIL ASSOCIATION, INCORPORATED

Article 2: The Place in this state where the principal office of the Corporation is to initially located is the City of JACKSONVILLE, FLORIDA 32224 County DUVAL
12126 CAP FERRAT STREET

Article 3: Said corporation is organized exclusively for charitable, religious, educational and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future tax code. The specific purpose of the corporation is to ENGAGE IN ALL ASPECTS OF PROPERTY IMPROVEMENT IN THE SANS PAREIL COMMUNITY. TO INCLUDE, BUT NOT BE LIMITED TO, ROAD DRAINAGE IMPROVEMENTS, ENTRANCE BEAUTIFICATION, SIGNAGE, AND OTHER IMPROVEMENTS AS PROVES NECESSARY.

Article 4: The corporation shall have 5 directors. The initial directors' name(s) and address(es) is/are:

Article 5: No part of the net earnings of the corporation shall inure to the benefit of any individual, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article 3 hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements), any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of the corporation.

Article 6: Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organizations, as said Court shall determine, which are operated exclusively for such purposes.
