ARTICLES OF INCORPORATION
CHAPTER 617, F.S., (NOT FOR PROFIT)

ARTICLE I NAME

The name of the corporation shall be:
Shri Saraswati Devi Mandir Inc.

ARTICLE II PRINCIPAL OFFICE

ARTICLE III PURPOSE

The objective and purpose of the Shri Saraswati Devi Mandir Inc. is to promote and preserve the religious and cultural aspects of Hinduism through harmony, peace, love, and justice based on the philosophy of Hinduism according to Sanatan Dharma.

All assets of the corporation shall only be used for the purpose as stated above, and not for the personal use of its members or directors.

ARTICLE IV MANNER OF ELECTION

The Founder/Spiritual Leader will appoint all officers and trustees who shall serve for a period of 1 yr.

The Spiritual Leader also reserves the right to discipline or reprimand any member of the Organization for inappropriate conduct if and when deemed necessary.

ARTICLE V PRIEST

Pandit Dave Purnanan Sharma, the founding Priest will remain the Spiritual Leader and priest-in-charge of the Shri Saraswati Devi Mandir Inc., until such time he relieves himself of his duties.

ARTICLE VI MEETINGS/AMENDMENTS

The executives will meet on the first Sunday of every month after service (approximately 1 pm). Emergency meetings will be determined as necessary by the President and secretary.

Any Amendments to the articles of incorporation may be made by the President & Executive Members but must be unanimously approved by the 9 executive officers.

The Spiritual Leader reserves the right to veto any decision made in the intent of the corporation, which he may deem inappropriate.

ARTICLE VII DISSOLUTION

In case of dissolution, after all expenses and payments are paid in full, the remaining assets shall be distributed to any not for profit organizations with similar objectives, which have qualified for exemption under section 501 C3 of the internal revenue code.


