ARTICLE OF INCORPORATION

ARTICLE I NAME

The name of the Corporation shall be Dr. Sharon Riggins-Patterson Child Development Academy, Inc.

ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:

2400 Chase Avenue P. O. Box 671 Sanford, Florida 32771

ARTICLE III PURPOSE (S)

Section 1: The Corporation is formed to provide <u>quality child care and academe</u> services commencing with infants and elementary school age students up to age 12 (before/after school care with tutoring).

Section 2: The goal and purpose of the Corporation is to help improve society by providing child care for students and a variety of on-going training for both school age individuals and adults of the community.

Section 3: The Corporation shall appoint a Board of Directors who shall have the power to oversee the operation of the Academy, raise funds and over-see the distribution of the funds.

Section 4: The Corporation shall have the power to function in all ways and extend its services as set forth in the Article of Incorporation.

Section 5: The Corporation shall be declared a non-profit organization and thus exempt from taxation.

ARTICLE 1V MANNER OF ELECTION OF DIRECTORS

Directors and Officers

The manner in which the directors are elected or appointed is, the original incorporator shall appoint the board of directors and its chairperson. These individuals shall remain in office as long as they are willing to uphold the purpose, and goals of DR. SHARON RIGGINS-PATTERSON CHILD DEVELOPMENT ACADEMY, INC.

SECTION 2: Directors and Officers may resign their position by sending a written statement to the registered agent.

SECTION 3: A director or officers may be asked to resign when the best interest of the Corporation is no longer demonstrated by his/her actions.

SECTION 4: The Board of Directors, upon consent to the Registered Agent and Director, shall make decision in the operation of the Corporation.

SECTION 5: All new board members shall be approved by the incorporator.

SECTION 6: The Board of Director shall consist of no less than three (3 and no more than seven (7) members.

ARTICLE V Financial Matters

SECTION 1: The Corporation shall have the power to solicit donations from both public and private individuals/business, etc.

SECTION 2: Directors and officers shall receive compensation for expenses that are related to the operation of the corporation

SECTION 3: Employees shall receive a salary that is commensurate with salaries in similar businesses.

SECTION 4: All promissory notes, bonds, deeds, and security deeds, mortgages and contracts of the Corporation shall be executed in the corporate name, and signed by the incorporator or the incorporator's appointee (s).

SECTION 5: Should the business dissolve, after all indebtedness have been paid, the remaining funds shall be donated to another not-for profit organizations.

ARTICLE VI ADMENDMENT TO BY-LAWS

These by-laws may be amended, altered, or added to as deemed necessary to carry out the goal and purpose of the Corporation.
