ARTICLE III PURPOSE

The purpose for which the corporation is organized is:

- f) To have power to take, purchase, lease, or otherwise acquire real estate, and to hold, own, sell, mortgage, lease, or otherwise dispose of same, and to build, construct, maintain, alter, and manage any building or buildings, or Church edifice for the uses or purposes of said Corporation.
- g) To have power to acquire, maintain and improve real property to be used as a campground for camp meeting purposes.
- h) To lead men and women to Jesus Christ according to the Holy Bible and to save and deliver souls regardless of race, color or creed.
- i) To establish, maintain and operate Day Care Centers, Orphanages, Homes for the Aged, and all other facilities necessary to aid the general public, in accordance with the tenets of worship.
- j) To engage in missionary work, ordain Ministers and to train missionary workers to teach the tenets of worship, as aforesaid, anywhere in the United States.
