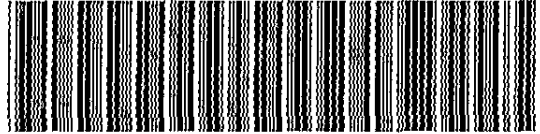

ARTICLES OF INCORPORATION

FOR

THE LIVING GOSPEL DOT COM, INC. A NOT FOR PROFIT CORPORATION

The undersigned, acting as Incorporator of a corporation under Chapter 617, F. S., adopts the following Articles of Incorporation for such corporation:

I. NAME

The name of the corporation is

II. PRINCIPAL OFFICE

III. PURPOSE

The purpose or purposes for which the corporation is organized is to facilitate the spread of the gospel of Jesus Christ to the world as commanded by Jesus Christ as he ascended in heaven. His words are recorded in Matthew 28: 19 and 20:

"Go ye therefore, and teach all nations, baptizing them in the name of the Father, and of the Son, and of the Holy Ghost: Teaching them to observe all things whatsoever I have commanded you: and, lo, I am with you alway, even unto the end of the world. Amen."

The mission of the Living Gospel Dot Com, Inc., its ownership, management, staff and outside consultant affiliations, will endeavor to lift the gospel as preached, sung, performed and illustrated in client churches. The end results shall be "city-centric" web sites, names after the city each web site represents, each consisting of web pages for client churches. Client web sites shall have rich multimedia files formatted in Real Player™, Media Player® and other formats for streaming audio and video across the Internet. The web sites shall incorporate testimonial pages, church announcements, directions and other pertinent information to allow web visitors to "spiritually" step inside each of the client churches and experience the essence of their worship experience.
