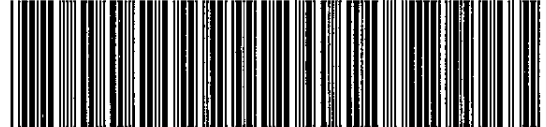

## **ARTICLES OF INCORPORATION**

In Compliance with Chapter 617, F.S., (Not for Profit)

### **ARTICLES I NAME**

The name of the corporation shall be:

WHITE STONE INTERNATIONAL, MIRACLES FROM ABOVE CHILDREN SERVICES, INC.

### **ARTICLES II PRINCIPLE OFFICE**

### **ARTICLES III PURPOSE**

The purpose for which the corporation is organized is:

To operate exclusively for Religion, Charity, Educational and Distinct Ecclesiastical purposes within the meaning of Section 501(c) (3) of the Internal Revenue Code of 1986.

To conduct Religious and Educational Activities – To organize and develop a multidisciplinary center to conduct, classes for children and families and community seminars and workshops to enhance growth and development for the total person. These centers will offer services for infants and children to be cared for in the absence of parents and guardians. This shall include before and after school services.

- A. The purposes for which this organization is organized are exclusively religious, charitable, scientific, literary and educational within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.
- B. Notwithstanding any other provisions of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.
- C. Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986, or corresponding section of any future Federal tax code, or shall be distributed to the Federal, state, or local government for a public purpose. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the organization is then located, exclusively for such purposes.

## **ARTICLES IV MANNER OF ELECTION**

The manner in which the directors are elected or appointed

1. Board vacancies will be advertised and posted on the Church Bulletins – Offices of Religious Organizations and Religious Educational Facilities, in the office of Children and Family Services and like agencies.
2. Résumé's of interested candidates will be required.
3. Selections will be made from résumé's.
4. The existing Board Members will vote from the selective names.
5. The Selected candidates will be notified by a written letter from the President of the Board.


