# ATTACHMENT TO ARTICLES OF INCORPORATION OF Interwoven Communities, Inc.

ARTICLE III PURPOSE: This Corporation shall be a nonprofit corporation. The purposes for which Interwoven Communities, Inc. is organized are exclusively charitable, educational and religious within the meaning of section 501 (c) (3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law. The specific purposes of this Corporation are: (a) to promote the arts and culture, and, specifically, but not limited to, poetry and poetry readings, and, (b) to educate the public on history, culture and the interrelationship between humanity and the environment.

ARTICLE VIII: Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501 (c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

ARTICLE IX: The property of this corporation is irrevocably dedicated to religious, educational and charitable purposes and no part of the net income of assets of this corporation shall ever inure to the benefit of any director, officer or member thereof or to the benefit of any private person. Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located exclusively for such purposes or to such organization or organizations, as said Court shall determine which are organized and operated exclusively for such purposes.
