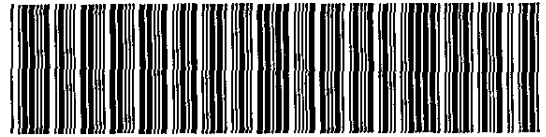

ARTICLES OF INCORPORATION OF

CreativeTampaBay, Inc.

Pursuant to Chapter 617, Florida Statutes, the Florida Not For Profit Corporation Act, the undersigned incorporators, being of full age, for the purpose of forming a not for profit corporation without capital stock, do hereby accept all of the rights, privileges, benefits, and obligations conferred and imposed by said law and do hereby make, subscribe, acknowledge, and file these Articles of Incorporation.

ARTICLE I

NAME

The name of this Corporation shall be "CreativeTampaBay, Inc."

ARTICLE II

CORPORATE PURPOSE

The Corporation is organized and shall be operated exclusively for charitable, scientific or educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, and its regulations as they may exist or as they may hereinafter be amended (or the corresponding provision of any future United States Internal Revenue Law (the "Internal Revenue Code")) to promote and support, directly or indirectly, by donation, loan or otherwise, the interests and purposes of the Corporation which is an organization described in Section 501(c)(3) of the Internal Revenue Code, and, in furtherance of these purposes the Corporation shall:

1. Govern and operate CreativeTampaBay, Inc. through regular meetings of the Board to create a grassroots movement in the Tampa Bay area with the express purpose of making the

community more attractive to creative workers.

2. Otherwise operate exclusively for charitable, scientific, or educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, in the course of which operation:

A. No part of its net earnings shall inure to the benefit or be distributed to any member, director, officer or other individual except in the form of reasonable compensation for services rendered to the Corporation which are unrelated to Board duties; and

B. No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office except as authorized under the Internal Revenue Code.

Notwithstanding any other provision of these Articles of Incorporation, the Corporation shall not carry on any activities not permitted to be carried on by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code.

ARTICLE III

INITIAL REGISTERED AGENT AND OFFICE

The initial registered agent of this Corporation shall be: Ronald A. Christaldi. The street address of the initial registered agent of this Corporation shall be: 101 East Kennedy Boulevard, Suite 3400, Tampa, Florida 33602.

ARTICLE IV

PRINCIPAL OFFICE

The mailing address of the Corporation and the street address of the initial principal office of this Corporation shall be: 3809 West Corona Street, Tampa, Florida 33629.

ARTICLE V

BOARD OF DIRECTORS

There shall be a Board of Directors for this Corporation which shall consist of not less than three (3) directors. The method of election of Directors shall be stated in the bylaws.

ARTICLE VI

INITIAL BOARD OF DIRECTORS
