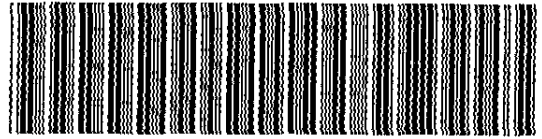

Articles of Incorporation

(In Compliance with Chapter 617, F.S., [Not for Profit])

FIRST: The name of the corporation shall be God's Abundant Supply, Inc. (hereinafter the "Corporation").

SECOND: The place in this state where the principal office of the Corporation is to be located is:

15041 Bridgeway Lane, No. 1001
Fort Myers, FL 33919-8450

THIRD: The Corporation shall be organized and operated exclusively for charitable, educational, religious and scientific purposes within the meaning of Code Section 501(c)(3) of the United States Internal Revenue Code of 1986 as amended (hereinafter "Code"), including, but not limited to:

- a) To provide worldwide financial, physical and spiritual sustenance directly to victims of famine, natural disasters, war, terrorism or other personal misfortune beyond the victims' control;
- b) The Corporation is also formed to develop, operate and maintain a chain of God's Abundant Supply, connecting those who give according to their ability to those who receive according to their need in obedience to Jesus' admonition in John 21:17 to "Feed my sheep." This organization will feed their souls through God's Word and feed their bodies in times of famine and disaster.
- c) The Corporation will assist other organizations, which serve as Christian Relief Organizations, lengthening and strengthening the chain to provide a wider outreach of Christian charity and enabling greater improvement for lives damaged by natural disasters or inhumane acts of others, or both.

FOURTH: No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons. Notwithstanding, the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered to the Corporation, to make reimbursements for expenses incurred in conducting its affairs and carrying out its purposes, and to make payments and disbursements in furtherance of the purposes set forth herein.

No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation. The Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office except as authorized under the Code, or the corresponding section of any future federal tax code.

The Corporation shall not carry on any other activities not permitted to be carried on:

- a) By a corporation exempt from federal income tax under Section 501(c)(3) of the Code, or
- b) By a corporation, contributions to which are deductible under Section 170(c)(2) of the Code, or the corresponding section of any future federal tax code.

In order to carry out only those general purposes heretofore set out, subject to the restrictions of Article 3, the Corporation shall have the following powers:

- a) To take and hold, by bequest, devise, gift, purchase or lease, either absolutely or in trust for such objects and purposes or any of them, any real, personal, or mixed property, without limitation as to amount or value, except such limitations, if any, as may be imposed by law.
- b) To sell, to convey, and to dispose of any such property and to invest and to reinvest the principal thereof, and to deal with and to expend the income therefrom for any of the aforementioned purposes, without limitation, except as may be imposed by law.
- c) To receive, take title to, hold, and use the proceeds and income of stocks, bonds, obligations or other securities of any corporation or corporations, domestic or foreign, but only for use in the purposes stipulated in Article 3 hereof.
- d) To do all things necessary and appropriate to the accomplishment of any of the objects and purposes for which this corporation is formed.

Notwithstanding any of the above statements of purposes and powers, this corporation shall not engage in activities which in themselves are not permitted to be conducted or carried on by an organization exempt under Section 501(c)(3) of the Code or by an organization, contributions to which are deductible under Section 170(c)(2) of the Code.

FIFTH: The Corporation shall have no members.

SIXTH: The initial Board of Trustees will be appointed by the Incorporator. Subsequent election or replacement of trustees will be as set forth in the Bylaws.

SEVENTH: The number of trustees constituting the first Board shall be three, and the names, positions held and addresses where the persons who are to serve receive all mail as such trustees are:

TENTH: The Corporation shall have all of the powers granted to nonprofit corporations by the statutes of the State of Florida, as amended from time to time.

ELEVENTH: Upon the dissolution of the Corporation, assets shall be distributed to other Christian Relief Organizations for one or more exempt purposes within the meaning of Section 501(c)(3) of the Code, or the corresponding section of any future federal tax code. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the Corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

TWELFTH: Every current or former corporate agent of the Corporation (as defined in Florida statutes) shall be entitled to indemnification to the full extent provided in the Florida act as in effect from time to time. The Corporation may purchase insurance for indemnification.
