Article I

Name

The corporation shall change its name from Sojourner Truth High School of Humanities & Technology to Truth Christian Academy and College Prep, Inc.

Article II

The principal place of business of the Corporation is 9319 Ridge Blvd., Jacksonville, Florida 32208, and the mailing address is P. O. Box 440087, Jacksonville, Florida 32222

Article III

Specific and General Purpose

The purpose or purposes for which the Corporation is organized is to qualify as an exempt organization under Section 501(c)(3) of the Internal Revenue Code and its Regulations as they now exist or as they may hereafter be amended and more specifically, to receive and maintain a fund or funds of real or personal property, or both, and, subject to the restrictions and limitations hereinafter set forth, to use and apply the whole or any part of the income thereof and the principal thereof to establish, acquire, own, maintain, operate, promote, support, and conduct Christian educational institutions under the Lordship of Jesus Christ for qualified persons without regard to race, color, national or ethnic origin, or sex, insofar as God provides the resources and ability to pay the Corporation.

Notwithstanding any other provisions of these articles of incorporation, this corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from federal income tax under section 501 (c)(3) of the Internal Revenue Code or corresponding provisions of any subsequent federal tax laws or by corporation contributions to which are deductible under section 170 (c)(2) of the Internal Revenue Code or corresponding provisions of any subsequent federal tax laws.

This corporation shall not, as a substantial part of its activities, carry on propaganda or otherwise attempt to influence legislation; nor shall it participate or intervene (by publication or distribution of any statements or otherwise) in any political campaign on behalf of any candidate for public office.

#### Article IV

##### Duration

This corporation shall exist perpetually.

#### Article V

To assure the Lordship of Jesus Christ, all those who become associated with Truth Christian Academy and College Prep as a trustee, administrator, officer, member of the Corporation must read, understand, accept, sign and display lives consistent with the following Statement of Faith;

- (1.) We believe that there is one God, eternally existent in three persons: Father, Son, and Holy Spirit.
- (2.) We believe in the deity of our Lord Jesus Christ, in His virgin birth, in His sinless life, in His miracles, in His vicarious and atoning death through His shed blood, in His bodily resurrection, in His bodily ascension to the right hand of the Father, and in His personal return in power and glory.
- (3.) We believe salvation is wholly dependent upon the work of God's free grace. Through acceptance of Jesus Christ we are rescued from our sins (Matthew 1:21), from bondage (Galatians 5:1), from perishing (Matthew 8:25), from this perverse generation (Acts 2:40), from the wrath of God (Romans 5:9), and from death (Romans 6:23).
- (4.) We believe that through the Holy Spirit we are convicted of our sins, drawn to the Savior, transformed and given new life, empowered and imparted gifts for service.
- (5.) We believe God has called us to a life of self-denying love and service.
- (6.) We believe the Lord Jesus Christ commands and therefore it is the obligation of all believers to proclaim the Gospel throughout the world and to make disciples of all nations by deed and word.
- (7.) We believe in the spiritual unity of believers in our Lord Jesus Christ.

The teachings of TRUTH CHRISTIAN ACADEMY AND COLLEGE PREP shall never be inconsistent with the above principles. No subsequent Board of Trustees or members shall ever be empowered to amend this Statement of Faith, and should, in the opinion of



two-thirds of the Board of Directors, TRUTH CHRISTIAN ACADEMY AND COLLEGE PREP at any time cease to teach and operate consistent with these principles, it shall be dissolved in accordance with the provisions of Article X herein.

#### Article VI

##### Membership

The members of this corporation shall be made up of the Board of Directors.

#### Article VII

##### Board of Directors

Management of the affairs of the Corporation is to be vested in the Board of Directors. The number of Board of Directors shall never be less than three (3) persons. The names and addresses of the persons serving as the directors are:

Distribution of Assets Upon Dissolution

Upon dissolution of the Corporation or the winding up of its affairs, the assets of the Corporation shall be distributed exclusively to charitable, religious, scientific, testing for public safety, literary, or educational organizations which would then qualify under the provisions of Section 501(c)(3) of the Internal Revenue Code and its Regulations as they now exist or as they may hereafter be amended, and its teaching and operation is consistent with the principles of the Statement of Faith in Article V.
