The undersigned, a majority of whom are citizens of the United States, desiring to form a Non-Profit Corporation under the Non-Profit Corporation Law of the State of Florida, do hereby certify:

FIRST:

The name of the corporation shall be:

Institute of Spiritual Formation John Paul II, Inc. (Instituto de Formación Espiritual Juan Pablo II, Inc.)

SECOND:

The place in this state where the principal place of business and mailing address of this corporation shall be located is at 500 N.W. 22 Ave., Miami,

Florida 33125

THIRD:

This corporation is organized exclusively for charitable, religious and educational purposes, including, for such purposes making of distributions to organizations under Section 501(c)(3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law).

The primary purpose of this non-profit corporation is to promote, encourage and provide spiritual formation in Catholic faith and doctrine as taught by the Magisterium of the Roman Catholic Church.

This corporation also have the power of purchasing, leasing, renting, selling, holding and otherwise acquiring, and disposing of real estate and personal property, both tangible and intangible, and chooses in action either as owner, broker, agent or factor, to purchase, acquire, deal in, sell, convey, transfer, etc. any type of property, business rights, franchises, for all purposes, subject laws to the foregoing limitations or for any other object in or about the business or affairs of said corporation without limit as to amount, to incur debts and to raise, borrow, and secure the payment of money in any lawful manner, including the issue and sale or other disposition of bonds, warrants, debentures, obligations, negotiable and transferable instruments and evidence of indebtedness of all kinds, whether secured by mortgage, pledge, deed of trust, or otherwise. This corporation shall have the power to carry on and perform all lawful business activities and acts, incidental, necessary,

proper and lawful in connection with the attainment of the objects of this corporation not-for- profit under the laws of this state, and in addition to guarantee the indebtedness of others.

FOURTH:

A Board of Trustees consisting of not less than three (3) and no more than twelve (12) Trustees shall govern the corporation.

The Board of Trustees shall have the power to add, alter, modify and rescind this Articles of Incorporation.

The Trustees of the Board shall elect members of the Board of Trustees every year and the election shall be decided by majority decision.

SIXTH:

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or otherwise intervene in (including the publishing of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by the corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law) or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code (or any corresponding provision of any future United States Internal Revenue Law).

SEVENTH:

Upon the dissolution of the corporation, the Board of Trustees shall, after paying or making provision for the payment of all the liabilities of the corporation, dispose of all assets of the corporation exclusively for the purposes of the corporation in such manner, or to such organization or organizations organized and operated exclusively for charitable, educational,

or religious purposes as shall at the time qualify as an exempt organization or organizations under section 501(c)(3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law), as the Board of Directors Trustees shall determine. Any such assets not so disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the corporation then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
