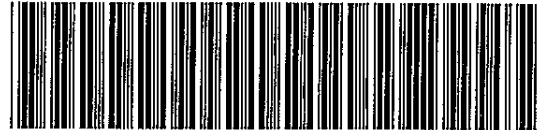

ARTICLES OF INCORPORATION
OF

A FLORIDA NOT-FOR-PROFIT ORGANIZATION

The undersigned, acting as the incorporator of a not for profit corporation under the Florida Not For Profit Corporation Act, as set forth in Chapter 617 of the Florida Statutes, as amended, adopts the following Articles of Incorporation for such Corporation:

Article I Name

The name of the corporation shall be: Miami-BAEO, INC, hereinafter referred to as the "Corporation".

Article II Principal Office

The address of the principal office and the mailing address of the corporation is
4030 N.W. 195 Street, Miami, Florida 33055.

Article III Purpose

The specific purpose for which this corporation is organized to educate citizens in general, and Black people in particular, about the importance of altering power arrangements that create ineffective and unacceptable educational systems for Black students.

Article IV Manner of Election

The Manner of Election of Directors for this corporation shall be governed by provisions contained in the organization's by-laws when they have been approved by the membership.

Article V Initial Directors and Officers

The Board of Directors shall consist of three (3) persons. The number of directors may be increased or decreased from time to time by an amendment to the bylaws; however, there shall never be less than three directors. All directors shall be selected as provided for in the bylaws.

Article VI Officers

The officers of the Corporation shall be a President, Vice President, Secretary, Treasurer, and such other officers as may be provided by the bylaws.

Article VII Amendments

These Articles of Incorporation may be amended at any regular or special meeting of the Board of Directors by a majority vote of those present; provided that notice of the intention to submit amendments shall have been given as provided by the bylaws.

Article VIII Initial Registered Agent and Street Address

The Corporation's registered office shall be located at 4030 NW 195th Street, Miami, Florida 33055; and Ron Butler is the registered agent of the Corporation at that address.

Article IX Incorporator

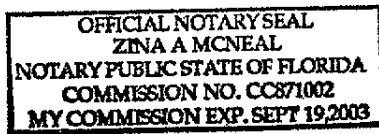
