ARTICLES OF INCORPORATION

SECRETARY OF STATE TALLAHASSEE, FLORIDA

BY THESE ARTICLES OF INCORPORATION the undersigned incorporator forms a corporation not for profit under Florida law.

ARTICLE I. NAME. The name of the corporation shall be UNTIL NOW, Inc.

ARTICLE II. PRINCIPAL OFFICE. The principal place of business and mailing address of this corporation is 1200 Anastasia Avenue, Suite 310, Coral Gables, FL 33134-6364.

ARTICLE III. PURPOSE.

A. The purposes for which this corporation is organized are the following:

This corporation is organized exclusively for educational and scientific purposes in the area of drug prevention and related fields, within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as now enacted or hereafter amended, including, for such purposes, the making of distributions to organizations that also qualify as Section 501(c)(3) exempt organizations. To this end, the purposes of the corporation shall be:

- 1. To provide financial and other assistance to domestic and foreign persons and entities, and in particular the Fundación Hasta Hoy and other Colombian organizations dedicated to the prevention of drug abuse among children.
- 2. To study methods for the prevention of drug use among young children with a view to adapting such methods for use in developing countries of Latin America.
- 3. To evaluate studies of the sociological factors contributing to drug abuse among young children and to contribute to the development of such studies.
- 4. To seek sources of volunteer workers, including, without limitation, psychologists, legal professionals, and medical specialists, willing to assist the corporation in its efforts to combat drug abuse among young children.
- 5. To develop elementary level educational programs alerting children to the dangers of drug abuse for use in schools established in areas particularly at risk in the area of drug abuse.
- 6. To develop ways and means of alerting the public to the needs of young children exposed to the dangers of drug abuse, such efforts to take the form of information conveyed by means of publications in all forms of media including print media, electronic

media and the internet and the organization of seminars, conventions and round tables, and potentially by maintenance of a web site.

- 7. To develop and maintain permanent contacts with other not for profit and government entities, domestic and foreign, public and private, able to assist the corporation professionally, administratively and commercially, and to coordinate with and support the efforts of other individuals, groups and organizations that have goals and purposes similar to those of the corporation.
- 8. To assist in encouraging and developing programs, both public and private, to prepare efficient and knowledgeable personnel, staff and employees able to assist in the efforts constituting the war against drug abuse among young children.
- 9. To promote cooperation with groups and organizations that defend the interests and rights of abused and exploited children in the United States and abroad.
- 10. To otherwise contribute in such ways as the Corporation through its Board of Directors shall consider appropriate to the development and publicizing of all of the above purposes, goals and principles.

B. Fiscal Considerations.

- 1. This corporation shall issue no stock.
- 2. No part of the net earnings of this corporation shall inure to the benefit of or be distributable to its members, directors, officers or other private persons except that this corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in this article.
- 3. No substantial part of the activities of this corporation shall consist of the carrying on of propaganda, or otherwise attempting, to influence legislation. This corporation shall not participate or intervene in any political campaign on behalf of any candidate for public office, including the publishing or distribution of statements.
- 4. Notwithstanding any other provision of these articles, this corporation shall not carry on any other activities which would constitute a regular business of a kind ordinarily carded on for profit, or which is not permitted to be engaged in by an organization exempt under Section 501(c)(3) of the Internal Revenue Code and its Regulations, as they now or hereafter exist.
- 5. On the dissolution of this corporation, the board of directors shall dispose of all of the assets of this corporation exclusively for the purposes of this corporation in the manner or to the organization or organizations that are organized and operated exclusively for the purposes appropriate for organizations that shall at the time qualify as

exempt organizations under § 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States internal revenue law, after paying or making provisions for the payment of all liabilities of this corporation. Any assets not so disposed of shall be disposed of by a court of competent jurisdiction in the county where the principal office of this corporation is then located exclusively for the purposes or to the organizations that the court determines are organized and operated exclusively for purposes acceptable for organizations that at the time qualify as exempt organizations under § 501(c)(3).

ARTICLE IV. <u>AUTHORITY</u>. The corporation shall be subordinate to and subject to the authority of the President of the Fundación Hasta Hoy, a Colombian not for profit corporation, who shall be sole voting member of the corporation.

ARTICLE V. MANNER OF ELECTION OF DIRECTORS. The method of election of directors shall be as stated in the Bylaws of the corporation.

ARTICLE VI. <u>INITIAL DIRECTORS AND OFFICERS</u>. The names and addresses of the members of the initial Board of Directors who, subject to these Articles, the Bylaws of the corporation, and the laws of the State of Florida, shall hold office until their successors have been duly elected and qualify:
