We, the undersigned, with other persons being desirous of forming a corporation for charitable and philanthropic purposes under the provision of section 617 the Florida Statutes, do agree to the following:

**ARTICLE I. NAME**

The name of this corporation is: THE CHURCH OF FAITH AND DELIVERANCE THROUGH CHRIST, INC.

**ARTICLE II. PURPOSES**

Said corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future tax code.

**ARTICLE III. LOCATION**

The location of this corporation shall be at 379 NW Long Street, in the city of Lake City, County of Columbia, State of Florida.

**ARTICLE IV. TERM OF EXISTENCE**

This corporation is to exist perpetual.

**ARTICLE V. QUALIFICATION OF MEMBERS**

## **ARTICLE VIII. NON-PROFIT STATUS**

No part of the net earnings of the corporation shall inure to the benefit of, or be distributed to any individual, members, officers, directors. The corporation shall not carry on propaganda, or otherwise act to influence legislation.

## **ARTICLE IX. BY-LAWS**

The Board of Directors of this corporation may provide such by-laws for the conduct of its business and the carrying out its purposes as they may deem necessary from time to time. Upon proper notice the By-Laws may be amended, altered or rescinded by a majority vote of those members of the Board of Directors present at any regular meeting or any special meeting called for that purpose.

## **ARTICLE X. AMENDMENTS**

These Articles of Incorporation may be amended at a special meeting of the membership called for that purpose, by a two-third majority vote of those present. Amendments may also be made at a regular meeting of the membership upon notice given, as provided by the by-laws, of intention to submit such amendments.

## **ARTICLE XI.**

In order to promote the purpose of this corporation, it may acquire property by grant, gift, purchase, devise or bequests, and hold and dispose of such property as the corporation shall require for the benefit of the members and not for pecuniary profit.

## **ARTICLE XII. DISTRIBUTION OF ASSETS UPON DISSOLUTION**

Upon dissolution of this organization all of its assets remaining after payment of all costs and expenses of such dissolution shall be distributed to organizations which have qualified for exemption under Section 501(c)(3) of the Internal Revenue Code, or the federal government, or to a state/local government, for a public purpose. Any such assets not so disposed of shall be disposed of by the Court of Common Pleas of the county in which the principle office of the organization is then located, exclusively for each purpose or to such organizations, as said Court shall determine, which are organized and operated exclusively for each purposes.
