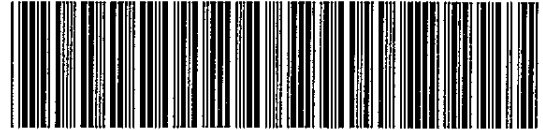

ARTICLES OF INCORPORATION  
OF The  
**Monarch Knights Spikers Club, Inc.**  
A Not for Profit Corporation

**ARTICLE I. NAME**

The name of the corporation shall be the Monarch Knights Spikers Club, Inc., which shall be a non-profit association

**ARTICLE II. PRINCIPAL OFFICE**

The principal place of business and mailing address of this corporation shall be:

**ARTICLE III. PURPOSE**

The purposes for which this corporation is organized are as follows:

- a. Acting as a not for profit organization and maintaining actions and policies consistent with the rules guiding Broward County Schools, as well as those related professional memberships held by the head coach, the corporation will provide physical and financial assistance which ultimately attain the head coach's goals and objectives solely for the volleyball program of Monarch High School and its community.
- b. To provide social and fraternal benefits which inherently flow from individuals interested in, and willing to work together for the education and sportsmanship of young people.
- c. To assist by a unified effort to give moral, physical, and financial assistance to those worthwhile projects which promote sports and sportsmanship activities in our school and community.
- d. To maintain a respect at all times for the coaching staff by giving the staff support, and refraining from any interference with any of the coaches in the performance of their duties.

**ARTICLE IV. MANNER OF ELECTION**

**Section 1. Officers**

- a. The officers of this corporation shall consist of a president, vice-president, secretary, treasurer, seargeant at arms, and concession manager.
- b. The term of office for all officers elected at the Annual Meeting in August shall begin in August and continue until the following August, or until new successors are elected.

**ARTICLE IV (continued)**

**Section 2. Elections**

Officers shall be elected by ballot at the Annual Meeting by a majority vote of the present volleyball parents.

**Section 3. Vacancies**

If a vacancy occurs on the executive board other than that of the president or vice president, the executive board may appoint a replacement. If a vacancy occurs in the office of president or vice president, a successor shall be elected at the next meeting.

**Section 4. Attendance**

If any officer is absent from two regular meetings in succession, unless excused by the executive board, the office will automatically become vacant and such vacancy filled as provided by Article IV Section 3.
