ARTICLE I - NAME

The name of this corporation is

PRIMERA IGLESIA CRISTIANA EN KISSIMMEE ASAMBLEAS DE DIOS, INC.

ARTICLE II - DURATION

This corporation shall have perpetual existence.

ARTICLE III - PURPOSE

The general nature and object of this corporation is for the purpose of establishing and maintaining a place for the worship of Almighty God, our Heavenly Father; to provide for Christian fellowship for those of like precious faith, where the Holy Ghost may be honored according to our distinctive testimony; and to assume our share of responsibility and the privilege of propagating the gospel of Jesus Christ by all available means, both at home and in foreign lands. We, whose names appear upon the roster of the Primera Iglesia Cristiana en Kissimmee Asambleas de Dios, Inc., do hereby recognize ourselves as a local assembly in fellowship with and a part of General Council of the Assemblies of God, with headquarters at 1445 Boonville Avenue, Springfield, MO and in fellowship with and a part of the Florida Multicultural District Council of the Assemblies of God, with headquarters at 830 California Woods Circle, Orlando, FL. The Corporation has the authority:

To build, construct, erect, and maintain mission stations and mission churches, pastor's home, and such other houses or equipment as the corporation may desire for carrying on its work.

To receive, administer, disburse and/or invest gifts, and bequests by or from any persons or corporations.

This corporation is further organized for the purpose of holding the title to such property or properties as Primera Iglesia Cristiana en Kissimmee Asambleas de Dios, Inc. shall from time to time purchase or acquire, and it shall have power from time to time to make such

contracts and do such things as shall be authorized and directed by its members. This corporation shall have the power to mortgage, sell, encumber deed or otherwise dispose of any property which may belong to Primera Iglesia Cristiana en Kissimmee Asambleas de Dios, Inc.

This Church membership shall have the right to govern itself according to the standards of the New Testament Scriptures: *"Endeavoring to keep the unity of the Spirit in the bond of peace. Till we all come in the unity of the faith, and of the knowledge of the Son of God, unto a perfect man, unto the measure of the stature of the fullness of Christ."* Ephesians 4: 3, 13

ARTICLE IV - MEMBERSHIP

The membership of the church formed by these Articles of Incorporation shall be made up of all persons who are presently members of Primera Iglesia Cristiana en Kissimmee Asambleas de Dios and those people who shall unite with this Church, by accepting our Constitution and Bylaws or by transfer of membership from other churches with the same doctrinal statements.

ARTICLE V - REGISTERED OFFICE AND AGENT

The street address of the registered office of this corporation is 2031 Simpson Road Kissimmee, Florida 34744, and the name of the registered agent of this corporation is Mariano Ayala.

ARTICLE VI - DIRECTORS

The election of Directors shall be pursuant to the Bylaws. The number of Directors constituting the Board of this corporation shall be five (5), and the names and addresses of the Directors as of this date are:


ARTICLE VII - DISSOLUTION


This corporation may be voluntarily dissolved by adherence to the following procedures as prescribed in Chapter 617 of the Florida Statutes. Articles of Dissolution and a Plan for Distribution of Assets shall be adopted by a Resolution approved by majority vote of the Board of Directors. The Resolution shall then be passed by a two-thirds vote of the corporation's members at a duly-noticed meeting. Assets remaining after payment of the corporation's debts shall be distributed, in accordance with the approved Plan, to one or more non-profit organizations engaged in activities substantially similar to those of Primera Iglesia Cristiana en Kissimmee Asambleas de Dios, Inc. The recipient organizations must be qualified under Internal Revenue Code Section 501(c)(3), or the corresponding section of any future federal tax code, for tax exempt status. No assets of Primera Iglesia Cristiana en Kissimmee Asambleas de Dios, Inc. may inure to the benefit of its members, officers, or directors, except as reasonable compensation for services rendered. The Articles of Dissolution and Plan of Distribution of Assets shall be filed with the Department of State in accordance with Florida Statutes.

ARTICLE VIII - AMENDMENTS

Amendments to these Articles of Incorporation may be proposed by a resolution adopted by the Board of Directors and presented to a quorum of members for their vote. Amendments may be adopted by a vote of two thirds of a quorum of members of the corporation.

IN WITNESS HEREOF, the undersigned two Directors of Primera Iglesia Cristiana en Kissimmee Asambleas de Dios, Inc. have executed these Articles of Incorporation, on behalf of the full Board and after proper approval by the members, this 21 day of August, 2016.





The restatement contains a full and complete text of the articles, including amendments which required member approval.

The amendments to the original articles were adopted in accordance with §617.1002, Fla. Stat., and executed in accordance with §617.01201, Fla. Stat. The board of directors adopted a resolution setting forth the proposed amendments and held a vote of the members at a duly-noticed meeting. A quorum of the voting members was present on August 21, 2016, and the number of votes cast for the amendments exceeded the two-thirds required by the articles, thus, was sufficient for approval (per §617.1006, Fla. Stat.).

The restated articles of incorporation supersede the original articles and all prior amendments.
