ARTICLES OF INCORPORATION  
OF

A Florida Not-for-Profit Corporation

ARTICLE I - NAME

The name of this corporation is PRIMERA IGLESIA CRISTIANA EN  
KISSIMMEE (DISCIPULOS DE CRISTO), INC.

ARTICLE II - DURATION

This corporation shall have perpetual existence and this existence shall commence  
on the date of execution and acknowledgment of these Articles.

ARTICLE III - PURPOSE

The not-for-profit corporation formed by these Articles of Incorporation is formed  
to carry on the work of the Primera Iglesia Cristiana En Kissimmee (Discipulos De  
Cristo), Inc., which purpose is as revealed in the New Testament, to win people to faith in  
Jesus Christ and commit them actively to the church, to help them to grow in the grace  
and knowledge of Christ that increasingly they may know and do his will, and to work  
for the unity of all Christians and with them engage in the common task of building the  
Kingdom of God, the Church is further organized for the purpose of cooperating with the  
Christian Church (Disciples of Christ) as part of the denomination, formerly brotherhood,  
known as Christian Church (Disciples of Christ).

ARTICLE IV - MEMBERSHIP

The membership of the Church formed by these Articles of Incorporation shall be  
made up of all persons who are presently members of the Primera Iglesia Cristiana En

Kissimmee (Discipulos De Cristo), and those people who shall unite with this Church by baptism through immersion or by transfer of membership from some other church.

ARTICLE V - INITIAL REGISTERED OFFICE AND AGENT

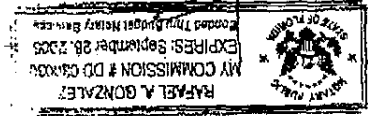
