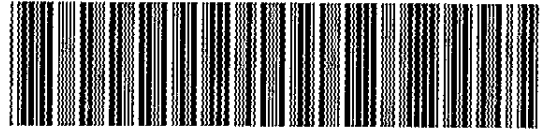

- ONE:** The name and address of this principal corporation is **Floyd Economic Development, Inc., 1313 Northwest 96th Street**, Miami, Florida 33147-4413, in Dade County. The corporation is organized pursuant to the **FLORIDA** Nonprofit Corporation Code Chapter 617.
- TWO:** This corporation is a nonprofit public benefit corporation and is not organized for the private gain of any person. The corporation is organized under the Nonprofit Public Benefit Corporation Law for, charitable and educational purposes to aid the poor and disadvantaged individuals and families towards a life of self-sufficiency. The programs will consist of, but shall not be limited to: Job Training, Job Placement, Land Acquisition, Housing, Employment, Literacy, Counseling, Temporary Shelter, Teenage Pregnancy, Mentoring Programs, Domestic Violence, Gang Involvement, Substance Abuse Awareness and Prevention, Tutoring, AIDS, Elderly Care and other programs to aid those in need.
- THREE:** The duration of this corporation shall be perpetual, having no stock, and shall have no members.
