ARTICLES ONE-NAME AND ADDRESS

- N. Other programs to aid those in need

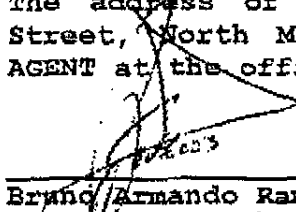
ARTICLE THREE-EXISTENCE OF CORPORATION

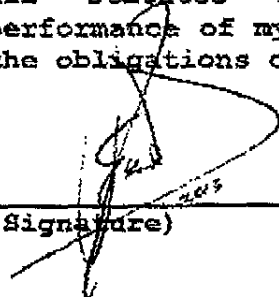
