## **Articles of Incorporation**

#### JOB CHRISTIAN FELLOWSHIP CHURCH

Name of Founder /President Rev. Roderick S. Love Sr.

#### **ARTICLES OF INCORPORATION**

#### ARTICLE I

The name of the corporation shall be <u>JOB CHRISTIAN FELLOWSHIP CHURCH</u>, INCORPORATED.

#### ARTICLE II

11040 Key Haven Boulevard Jacksonville, Florida 32218

#### ARTICLE III

The purposes of which the corporation is organized are: to operate exclusively for religious, charitable, educational and distinct ecclesiastical purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, or the corresponding provision of any future United States Internal Revenue law thereto, and such purposes shall include the following:

- (a) Religious.
- (b) To conduct a local church by the direction of the Lord Jesus Christ and under The leadership of the Holy Spirit in accordance with all of the commandments and provisions as set forth in the Holy Bible, the irrevocable Word of God. Pursuant thereto, the following activities and guidelines shall be established:
  - i. Develop within each member a measurable sense of love for God, themselves and others through their spiritual, mental and physical actions, based upon Biblical principles, equipping them for ministry to announce the good news of Jesus Christ to the world. So that every person has an opportunity to make a decision for Jesus Christ as Lord and Savior of their life.
  - ii. An ecclesiastical form of government.
  - iii. Ordination of ministers upon completion of the prescribed course of study, Designated by this church ministry.
  - iv. An organization of ministers shall be established to minister to the Congregation of JOB CHRISTIAN FELLOWSHIP CHURCH INCORPORATED.
  - v. Establishment of a congregation membership based upon acceptance of the Vision, mission, strategy, structure, beliefs, and responsibilities of the church.
  - vi. Spread the Word of the Gospel through seminars, radio, television, Establishment of church literature and other forms of mass media for the Purpose of educating the individual in the Word of God.
  - (c) Minister the Word of God to the faithful, and all others.
  - (d) To acquire and hold such property, either real or personal, for church Purposes, as may be necessary for its membership and the worship of God for never ending services.

#### ARTICLE IV

In accordance with and in addition to the powers conferred by the laws of the State of FLORIDA, the Non-profit Corporation shall have the following power:

- (a) To receive and accept gifts of money and property and to hold the same for any of the purposes of the Corporation and its work.
- (b) To receive and assist in accepting funds for the purposes herein set forth, including the issuance of bonds or other instruments of credit.
- (c) To acquire, own lease, mortgage and dispose of property both real and personal.
- (d) To conduct and carry on religious services and instruction through the public media, including electronic broadcasting, AM and FM radio, telecasting, microwave distribution, closed circuit transmission and cable television.
- (e) To acquire, own and operate such broadcasting and/or telecasting facilities.
- (f) To accept property and donations in trust for religious or charitable purposes.

#### ARTICLES V

JOB CHRISTIAN FELLOWSHIP CHURCH, INCORPORATED is organized under a non-stock basis.

#### ARTICLE VI

The Board of Directors shall be three or more in number, their names and addresses being as follows:

#### ARTICLE VII

The name and address of each incorporator are the same as states in Article VI.

#### ARTICLE VIII

JOB CHRISTIAN FELLOWSHIP CHURCH, In Corporated's Board of Directors shall manage the business and property of the church. The present Directors shall hold offices until further election. In the event of the inability of any Director to act, or in the event of the death of a Director, the remaining Directors shall elect another Director to fill the vacancy or vacancies, thus created. Each Director shall be a member in good standing of the corporation.

The board of Directors shall reserve the right to amend these Articles and the By-laws by a majority vote. This is to be done to further meet the needs of the corporation.

#### ARTICLE IX

The principal office of the <u>JOB CHRISTIAN FELLOWSHIP CHURCH</u>, INCORPORATED shall be 11040 Key Haven Boulevard, in the city of JACKSONVILLE, the state of FLORIDA, and the county of DUVAL.

#### ARTICLE X

There shall be but one class of membership in this corporation. Membership in this corporation may be obtained by natural persons of all races, creeds and colors who shall publicly profess belief in Jesus Christ as their personal Savior, and who shall further profess their belief in the purposes of this organization as set forth herein above, and who shall thereafter be accepted into membership in such a manner as provided by the Board of Directors of this corporation.
