**ARTICLES OF INCORPORATION  
OF

( A FLORIDA NOT-FOR-PROFIT)**

*The undersigned, acting as a corporation pursuant to chapter 617 Florida Statutes adopts the following Articles of Incorporation.*

**ARTICLE I  
NAME**

*The name of the corporation shall be:*

**ARTICLE II  
PRINCIPAL PLACE OF BUSINESS AND BUSINESS ADDRESS**

*The principal place of business and mailing address of the corporation shall be:*

**ARTICLE III  
PURPOSE**

*The specific purposes for which the corporation are organized are as follows:*

- 1. To provide job training and placement for the socially and economically disadvantaged.*
- 2. Development of a welfare reform program.*
- 3. To serve as a bridge between the community and business through the development of interest in entrepreneurship.*
- 4. To create a lower income housing finance program.*

- 5. To engage in any other legal business necessary to the achievement of corporate goals.***
- 6. The purposes for which the corporation is organized are exclusively Charitable and educational within the meaning of section 501 (c ) (3 ) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.***

#### ***ARTICLE IV DIRECTORS***

***The initial Board of Directors will be appointed by the original incorporators.***

#### ***ARTICLE V LIFE OF CORPORATION***

***Life of the corporation will be perpetual unless dissolved by resolution of the Board of Directors or and act of law.***

#### ***ARTICLE VI POWERS***

***Notwithstanding any other provision of these articles, the organization will not carry on any activities not permitted to be carried on by an organization exempt from federal income tax under 501 (c ) (3 ) of the internal Revenue Code of 1986 or ant corresponding provision of any future United States Internal Revenue Law.***

#### ***ARTICLE VII BYLAWS***

***By laws of the corporation will be formulated and implemented by the initial Board of Directors once appointed by the incorporators.***

**ARTICLE VIII  
DISSOLUTION**

*Upon dissolution of the corporation either as an act of law or by resolution of the board of Directors of the corporation assets will be*

*distributed to a non-profit 501 (c ) (3) corporation. " However, if named recipient is not then in existence or no longer qualified as a distributee, or unwilling or unable to accept the distribution, the assets of the organization will be distributed to a fund, foundation, or organization which is operated exclusively for the purposes specified in section 501 (c ) (3) of the internal revenue code.*
