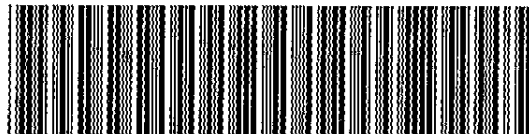

ARTICLE IV - MANNER OF ELECTION OF DIRECTORS


