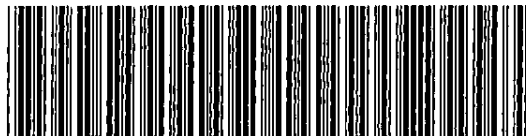

Amendments adopted totally replaces existing Article III:

**ARTICLE III**

The general nature of the business or Business to be transacted by said corporation shall be as follows:

To foster, support, and engage in activities relative to humanitarian relief, socioeconomic development, progress and ideals, including any and all activities, which are lawful and appropriate in accordance with the laws of the State of Florida. The organization shall engage in activities and programs that serve to promote socioeconomic, cultural and human development, mutual understanding, and public understanding among the different ethnic groups living in the State of Florida.

That of engaging in any activity permitted under the laws of the United States of America, its territories, districts, and possessions, and any activity permitted under the laws of the State of Florida, and to have, exercise, and enjoy the powers and privileges granted to corporations not for profit by Chapter 617, Florida Statutes.

To do all and everything necessary, suitable, and proper for the accomplishment of any of the purposes, of the attainment of any of the objects, or for the furtherance of the powers herein set forth, either alone or in association with other corporations, firms, or individuals, and to do every other act or acts, thing or things, incidental or appurtenant to or growing out of or connected with the aforesaid business of powers, or any part thereof; provided, that the same be inconsistent with the laws under which this corporation is organized.

The purpose for which Empowered Youth, Inc. is organized are exclusively charitable, scientific, literary, and educational purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding section of any future federal tax code.

In pursuit of its goals, the organization shall establish the following objectives:


- 1) To establish comprehensive homebuyer, budgeting and finances for persons of low-moderate income.
- 2) To organize activities which serve to promote homeownership and other micro ventures among low-income persons.
- 3) Create opportunities and resources for youth in detention through the development of partnerships with existing community and business organizations that provide Mentoring, Entrepreneurship Training, Networking, and Outreach to engage youth with community service opportunities designed to restore safe neighborhoods, healthy environments, job placement and vocational training.
