ARTICLES OF INCORPORATION

North Miami Beach Water Fund, Inc.

A Florida Nonprofit Corporation

The undersigned, acting as the incorporator of a corporation pursuant to Chapter

Statutes, adopt the following Articles of Incorporation:

ARTICLE I Name

The name of the corporation shall be North Miami Beach Water Fund, Inc.

ARTICLE II Principal place of business and mailing address

The principal place of business and mailing address of this corporation shall be:

17011 N.E. 19th Avenue North Miami Beach, Florida 33162

ARTICLE III Purpose

1. The purpose of the Corporation is to provide financial and technical support to the City of North Miami Beach in the areas of water and environmental resources. Specifically, the Corporation will fund and support water resource development and conservation; water supply and treatment infrastructure; water and energy conservation measures; flow reduction and management measures; water and sanitary conveyance; development and implementation of water reclamation and reuse alternatives; enhancement of environmental and water resource protections; and the education of City staff, corporate employees and consultants in the areas listed above.

- 2. The Corporation is organized to be a not-for-profit corporation organized pursuant to Chapter 617, Florida Statutes, and may engage only in activities that may be carried on by a corporation exempt from federal income taxes under Section 501(c)(3) of the Internal Revenue Code or any section of any statute adopted in succession thereof. No part of the net earnings of the Corporation shall inure to the benefit of any director or officer, except that the Corporation may pay reasonable compensation for services rendered and may make payments and distributions in furtherance of the purposes set forth herein.
- 3. The Corporation is organized to exercise and enjoy all other powers, rights, and privileges granted by the laws of this State, and all the powers conferred by all acts heretofore or hereafter amendatory of or supplemental to the statute, and the enumeration of certain powers as herein specified is not intended as exclusive of or as a waiver of any of the powers, rights, or privileges granted or conferred by that statute now or hereafter in force; provided, however that nothing herein contained shall be deemed to authorize or permit this Corporation to carry on any business, to exercise any power, or to do any act which a company formed under that statute may not at the time lawfully carry on or do.

ARTICLE IV Manner of election of directors

The manner in which the directors are elected or appointed is by election at the annual meeting of the Board of Directors of North Miami Beach Water Fund, Inc., or as otherwise stated in the Bylaws.

ARTICLE V Limitation of corporate powers

There are no provisions which limit the corporate powers authorized under Section 617.0302, Florida Statues.
