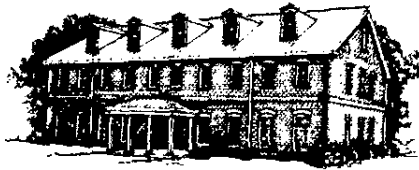



ARTICLE I - NAME

The name of this corporation is Friends of the Milton Gardens, Inc.

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

ARTICLE III - PURPOSE

This corporation is organized for the following purposes:

- A. To create a greater awareness and appreciation of **The Milton Gardens** and encourage the use of **The Milton Gardens** as a public garden to promote a better neighborhood and community.
- B. To raise funds to contribute to the SHARE program of the University of Florida Foundation, Inc. to provide scholarships to students of the environmental horticulture programs on the Milton Campus of the University of Florida.
- C. To expand the role of **The Milton Gardens** to foster research and provide horticultural education programs through partnerships with schools, community organizations, and the horticulture industry.
- D. To provide operational funds for implementation of research, community outreach, and educational programs of **The Milton Gardens** by soliciting gifts, bequests, grant funds, volunteer time, equipment, materials, services, and art.

ARTICLE IV - INITIAL REGISTERED OFFICE AND AGENT

The mailing and street address of the principal office of this corporation is the same and is 5988 Hwy 90, Bldg. 4900, Milton, FL 32583. The name and address of the initial registered agent of this corporation is Jennifer Byrom, 5177 Elmira Street, Milton, Florida 32570. The certificate designating the Registered/Agent/Registered Office is attached and incorporated herein.

ARTICLE V - INITIAL BOARD OF DIRECTORS


