 - 10. TO RECOGNIZE, SUPPORT AND COOPERATE WITH THE VARIOUS MINISTRIES ESTABLISHED BY GOD TO EQUIP BELIEVERS TO FULFILL THEIR RESPECTIVE FUNCTIONS AS MEMBERS OF THE BODY OF CHRIST AND TO BRING THE WHOLE BODY OF CHRIST TO MATURITY AND COMPLETION.

- 11. TO ORDAIN MINISTERS: TO ASSIST IN THE ESTABLISHMENT AND MAINTENANCE OF OTHER CHURCHES: AND TO SEND FORTH MISSIONARIES FOR THE ESTABLISHMENT AND UPBUILDING OF OTHER CHURCHES, BOTH DOMESTIC AND FOREIGN.
- 12.
