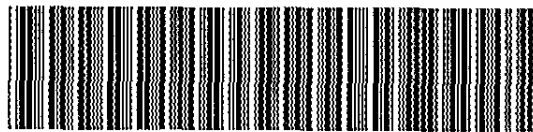

The undersigned, acting as incorporator(s) of a Corporation pursuant to Chapter 617, Florida Statutes, adopt(s) the following Articles of Incorporation of such corporation:

**ARTICLE I - NAME AND PRINCIPAL ADDRESS**

The name of this corporation shall be:

**SOS FOUNDATION FOR KIDS, INC.**

The principal place of business of this corporation shall be:

**ARTICLE II**

The period of the duration of this corporation is perpetual unless dissolved according to law.

**ARTICLE III**

The purposes for which the corporation is organized are:

To act as an agent to collect revenues from the Annual Sarasota Offshore Showdown, and immediately disperse such revenues to any qualified non-profit 501 (C) 3 agency or organization in Sarasota County, Florida which provides services that benefit the health and welfare of children of Sarasota County, Florida

**ARTICLE IV**

The qualifications for members and the manner of their admission are:

Members of the corporation may be any interested party who is a member in good standing of the Sarasota Offshore Showdown Race Committee. Members shall be chosen annually, by application and vote of the standing committee of the Sarasota Offshore Showdown.

#### ARTICLE V

#### ARTICLE IX


The organization is organized exclusively for charitable, religious, educational, and/or scientific purposes under section 501 (c) (3) of the Internal Revenue Code.

No substantial part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of this document, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170 (c) (2) of the Internal Revenue Code, or corresponding section of any future federal tax code.



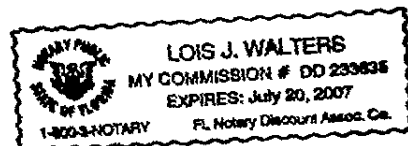
