ARTICLES OF INCORPORATION
OF
RANCHERS FOR BETTER GOVERNMENT --- AND WORLD PEACE,
INC.

(A Florida Not for Profit Corporation)

The undersigned, being of legal age and a natural person, do hereby subscribe to, acknowledge and file the following Articles of Incorporation for the purpose of creating a corporation under the laws of the State of Florida.

ARTICLE I

NAME

The name of this corporation shall be RANCHERS FOR BETTER GOVERNMENT --- AND WORLD PEACE, INC. and the initial address of this corporation shall be 13521 Old Sheridan Street, Southwest Ranches, Florida, 33330, hereinafter called the "Corporation."

ARTICLE II

PURPOSE

This corporation may engage in any activity or purpose permitted to be transacted by a not for profit corporation under the laws of the United States or the State of Florida. Notwithstanding the foregoing this Corporation shall not (a) engage in any endeavor for profit (with the exception of incidental bank interest or incidental income); and (b) pay earnings for the benefit of a private member or individual.

Further specifying the purposes of this organization that are beneficial to the public interest, without otherwise limiting corporate power and authority, are the following: (a) to provide a public forum for discussion of items relevant to the residents, property owners and business people of Southwest Ranches, Florida; and (b) to develop a dedicated and concerned membership that actively strives, individually and collectively, to ensure that the democratic process of government is not subverted by elected officials, bureaucrats, and special interest groups.

ARTICLE III

BEGINNING OF CORPORATE EXISTENCE

This corporation shall have perpetual existence commencing the date of subscription and acknowledgment hereof as provided by Florida Statute 617.0203, unless sooner dissolved according to law.

ARTICLE IV

PRINCIPAL OFFICE AND MAILING ADDRESS

The address of the principal office of the corporation is 13521 Old Sheridan Street Southwest Ranches, Florida 33330. The mailing address of the Corporation is the same. The Board of Directors may from time to time move the principal office to any other address.

ARTICLE V

BOARD OF DIRECTORS AND OFFICERS

The affairs of this Corporation shall be managed by a Board of Directors consisting of no less than three (3) directors. The number of directors may be increased or decreased from time to time, in accordance with the Bylaws of the Corporation, but shall never be less than three. The manner of election of directors shall be regulated by the Bylaws.

The initial Directors and Officers of the Corporation shall be:

Director and Secretary: Marcia Larkin 16711 SW 52nd Place, Southwest Ranches, Florida 33331.

Director and Treasurer: Dennis Hugdahl 13870 Mustang Trail, Southwest Ranches, Florida 33330.

ARTICLE VI

NOT-FOR-PROFIT ORGANIZATION

This Corporation is organized under a non-stock basis and shall at all times be operated as a not for profit organization.

ARTICLE VII

INCORPORATOR

The name and address of the Incorporator is:

ARTICLE VIII

REGISTERED OFFICE AND REGISTERED AGENT

The street address of the initial registered office of the Corporation is 13521 Old Sheridan Street, Southwest Ranches, Florida 33330; and the name of the Corporation's registered agent at that address is Roger Osborne.

ARTICLE IX

MEMBERSHIP

Any person, corporation, partnership, association or organization, who is interested in the purposes of the Corporation, who is capable of contributing to the achievement of those purposes and the effective operation of the Corporation, and who complies with the requirements established from time to time by the Bylaws, shall be eligible for membership.

ARTICLE X

AMENDMENTS

These Articles of Incorporation may be amended in the manner provided by law. Every amendment shall be approved by the Board of Directors, proposed by it to the members and approved at a meeting by majority of the members present, unless all the directors and all the members sign a written statement manifesting their intention that a certain amendment of these Articles of Incorporation be made.
