ARTICLES OF INCORPORATION  
OF  
CITIZENS FOR A FAIR SHARE, INC.  
A FLORIDA NONPROFIT CORPORATION

ARTICLE ONE

**Name**

The name of the Corporation is Citizens for a Fair Share, Inc.

ARTICLE TWO

**Principal Office and Address**

ARTICLE THREE

**Duration**

The term of existence of the Corporation is perpetual; and the corporate existence will commence on the filing of these articles by the Department of State.

ARTICLE FOUR

**Purpose**

The purposes for which the Corporation is organized are:

A. To accomplish meaningful tort reform in the state of Florida, including but not limited to, the advancement of and opposition to certain constitutional amendment initiatives in the

state of Florida.

B. To carry out these objects of the corporation as a business league not organized for profit, and no part of the net earnings shall inure to the benefit of any private member or individual, as an exempt corporation not for profit.

C. To do anything necessary and proper for the accomplishment of any purposes set forth above.

## ARTICLE FIVE

### **Membership**

Any person or entity that desires to accomplish meaningful tort reform in the state of Florida is eligible for membership.

## ARTICLE SIX

### **Directors**

The method of election of the directors of the Corporation is set forth in the bylaws.

## ARTICLE SEVEN

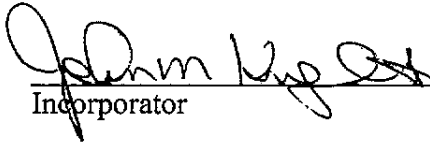
