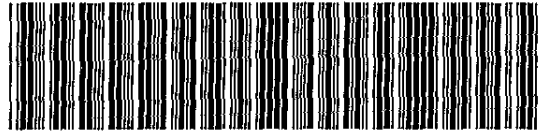

Articles of Incorporation
of

The undersigned subscribers to these Articles of Incorporation, desiring to form a Not-For-Profit Corporation under the laws of the State of Florida, do hereby accept all of the rights and privileges, benefits and obligations conferred and imposed by said laws and do hereby adopt the following Articles of Incorporation as the Charter of the Corporation hereby organized.

Article I. Corporate Name

Article II. Terms of Existence

This corporation shall have: Perpetual Existence.

Article III. Purpose and Powers

This Non-Profit Corporation is organized for the purpose of engaging in religious, charitable, spiritual, motivational, educational and charitable missions to assist persons toward a life of self sufficiency. Further, the organization will institute **Local, National and International** Seminars and Lectures on varied topics of **Female Interest**. All of the contained programs and services are will be operated within the guideline and meaning of the state of Florida's non-profit corporations and in accordance of the Federal Tax Exempt Statues within the meaning of the 501(c)(3).

Article IV. Capital Stock

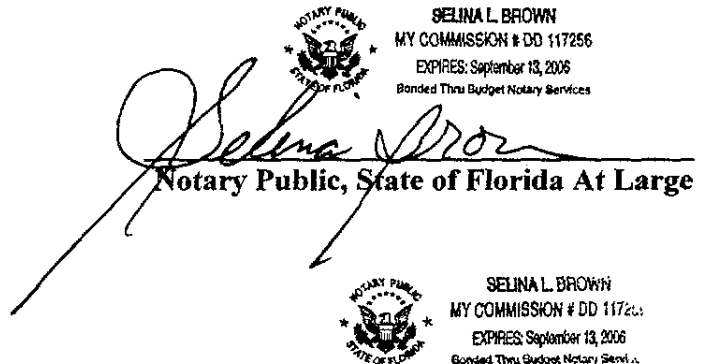

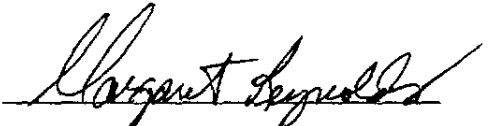
