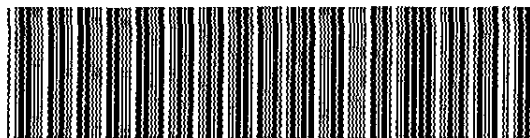

ARTICLE 1- NAME

The name of the corporation is: Divine Healing Apostolic International Center, Inc.

ARTICLE 2- PRINCIPAL OFFICE

ARTICLE 3 - PURPOSE

This corporation is a non-profit religious benefit corporation and is organized to spread the gospel of Jesus Christ. The corporation is organized under the Non-Profit Public Benefit Corporation Law for Religious purposes. To establish structured support service for Evangelistic, Economic Development, and other Ministries, to support the outreach ministries for the body of Jesus Christ (The Church). In accordance with the doctrine of the corporation creed/by-laws as a pastor to spread the gospel of Jesus Christ. The religious program will consist of Economic Development Programs, but shall not be limited to: Homeless, Health Care, Child Care, Youth At Risk, Tutorial, Land Acquisition, Housing, Job Training, Counseling, Employment and other programs to aid those in need.

ARTICLE 4 - NON-MEMBERSHIP

The duration of this corporation shall be perpetual, no stock, and shall have no members

ARTICLE 5 - REGISTERED AGENT

ARTICLE 6 - ORGANIZATION

- (A) This corporation is organized and operated exclusively for Religious purposes within the meaning of Section 501 (c) (3) of the Internal Revenue Code.
- (B) Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to carry on (1) by a corporation exempt from federal income tax under Section 501 (c) (3) of the Internal Revenue Code or (2) by a corporation contributions to which are deductible under Section 170 (c) (2) of the Internal Revenue Code.
- (C) The property of this corporation is irrevocably dedicated to Religious purposes and no part of the net income or assets of the organization shall ever inure to the benefit of any director, officer or member thereof or the benefit of any private person.

ARTICLE 7 - DIRECTORS

Upon the dissolution or winding up of the corporation, its assets remaining after payment of, or provision for payment of all debts, and liabilities of this corporation, shall be distributed to a non-profit fund, foundation, or corporation, which is organized and operated exclusively for Religious under Section 501 (c) 3 of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government for a public purpose. Any such asset not disposed of shall be disposed of by the organization located exclusive for such purposes or to such organizations, as said court shall determine which are organized and operated exclusively for such purposes.
