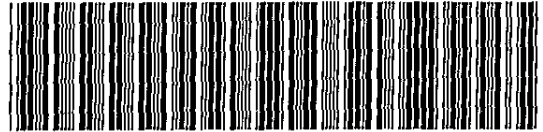

ARTICLES OF INCORPORATION

OF

SCIENCE SPEAKS, INC.

The undersigned, acting as incorporator pursuant to and in compliance with Chapter 617 of the Florida Statutes, adopts the following Articles of Incorporation:

Article I.

NAME

The name of this corporation is SCIENCE SPEAKS, INC.

Article II.

INITIAL PRINCIPAL OFFICE

The physical address of the principal office of the corporation is 3 Island Drive, Lake Mary, Florida 32746, and the mailing address of the corporation is 3 Island Drive, Lake Mary, Florida 32746.

Article III.

DURATION

The period of the corporation's duration is perpetual, beginning from the date these Articles are filed with the Secretary of State.

Article IV.

PURPOSE

The purpose for which this corporation is organized is to establish and maintain an organization to facilitate and encourage open, respectful dialogue in matters of science and the origins of life in order to know the truth and purpose behind the universe and all things in it, through educational, literary and related or similar programs. The corporation shall have the power, as needed, to effectuate the foregoing described purpose, to take, buy, manage, hold, sell, and dispose of the property, both real and personal, of this corporation, subject to such rules and regulations, if any, as the corporation may adopt. The purposes of the corporation shall be exclusively charitable, religious, scientific, educational or some combination thereof. The corporation is not formed for pecuniary or financial gain, and no part of the assets, income, or profit of the corporation is distributable to, or inures to the benefit of its directors or officers except to the extent permitted under the Florida Not for Profit Corporation Act. No substantial part of the activities of the corporation shall be the carrying on of propaganda or otherwise attempting to influence legislation and the corporation shall not participate in or intervene (including the publishing or distribution of statements) in any political campaign on behalf of any candidate for public office. This corporation shall have only those powers permitted under the laws of the United States and the State of Florida necessary to effectuate purposes specifically described herein. Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the above stated purposes of this corporation.

Article V.

DISSOLUTION

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

Article VI.

INITIAL BOARD OF DIRECTORS

This corporation shall have eleven (11) directors initially. The number of directors may be increased or decreased from time to time by an amendment of the By-Laws of the corporation in the manner provided by law, but shall never be less than three (3). The members of the Board of Directors shall serve until the election and qualification of their successors. The method of electing directors shall be set forth in the Bylaws.

BY-LAWS

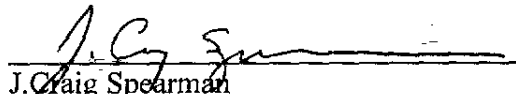

AMENDMENTS

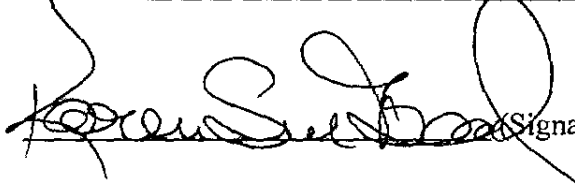

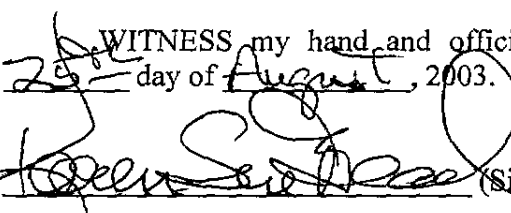
