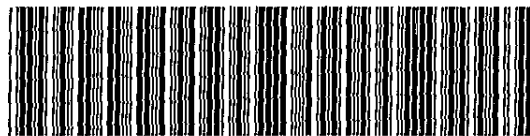

ARTICLE I NAME

Section 1.1 The name of this not for profit corporation shall be:

ARTICLE III EFFECTIVE DATE

Section 3.1 The effective date of these Articles of Incorporation shall be the date these articles are filed with the Secretary of State.

ARTICLE IV PURPOSE

Section 4.1 The specific purpose for which the corporation is organized is to establish and operate a not for profit church or churches or any related religious programs and for any other lawful purpose under the Florida Not for Profit Corporation Act, and to distribute the income therefrom exclusively for charitable, scientific, literary, or educational purposes, directly or by contribution.
