The undersigned incorporate, for the purpose of forming a corporation under the Florida Not for Profit Act, hereby adopt(s) the following Articles of Incorporation:

ARTICLE I - NAME

The name of the corporation shall be:

ARTICLE II - PRINCIPAL OFFICE

ARTICLE III - PURPOSE(S)

The specific purpose for which the corporation is organized is:

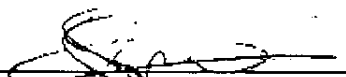
H03000264635 1**ARTICLE XI - CORPORATE ACTIVITIES**

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

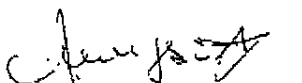
ARTICLE XII - DISSOLUTION

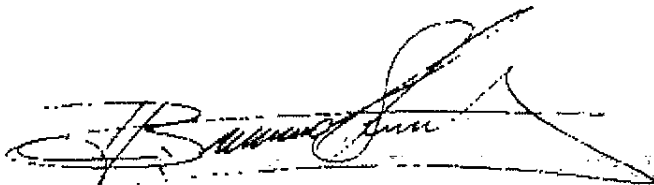
