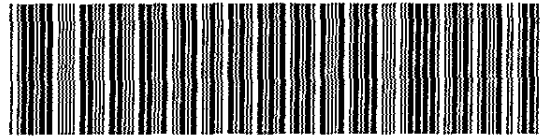

ARTICLES OF INCORPORATION FOR
NORTH VILLAGE BUSINESS CENTER ASSOCIATION, INC.
IN COMPLIANCE WITH FLORIDA STATUTES CHAPTER 617 (NOT FOR PROFIT)

THE UNDERSIGNED, hereby makes, executes and adopts the following Articles of Incorporation:

ARTICLE I. NAME. The name of this Corporation shall be:

NORTH VILLAGE BUSINESS CENTER ASSOCIATION, INC.

ARTICLE II. PRINCIPAL OFFICE. The principal place of business and mailing address of this corporation shall be 8910 North Dale Mabry, Suite 36, Tampa, Florida 33614.

ARTICLE III. PURPOSE. The purpose for which this corporation is organized is to manage and enforce the terms and provisions of the Declaration of Covenants, Easements and Restrictions, as well as manage the common areas of North Village Business Center as a recorded plat of lands in Hillsborough County, Florida, and to engage in any lawful purpose or purposes in compliance with Florida Statute Chapter 617 as a not-for-profit corporation.


