ARTICLES OF INCORPORATION  
OF

PINECREST NORTH ESTATES HOMEOWNERS ASSOCIATION, INC.

The undersigned incorporator hereby adopts these Articles of Incorporation under and pursuant to the laws of the State of Florida regarding corporations not for profit, Fla. Stat. 617.01 et seq., and the acts amendatory thereof and supplemental thereto, do hereby certify as follows:

ARTICLE I  
NAME

The name of this corporation is PINECREST NORTH ESTATES HOMEOWNERS ASSOCIATION, INC.

ARTICLE II  
DURATION

The duration of the corporation shall be perpetual.

ARTICLE III  
MEMBERSHIP

- A. Each lot owner shall automatically be Members of the Association.
- B. Membership shall commence upon the acquisition of fee simple title to a lot as evidenced by the recording of a deed of conveyance amongst the Public Records of Miami-Dade County, Florida or, as provided in the Declaration of Covenants, Conditions and Easements to be recorded in the Public Records of Miami-Dade County, Florida, and Membership shall terminate

upon the divestment of title to said lot.

C. On all matters as to which the Membership shall be entitled to vote, there shall be only one vote for each Lot, which vote shall be exercised in the manner proved by the Declaration or the By-Laws.

D. The share of a Member in the assets of the Association cannot be assigned, hypothecated or transferred in any manner except as an appurtenance to his Lot.

E. The manner in which the Directors are elected is set forth in the By-Laws of the Corporation.

#### ARTICLE IV INCORPORATION

The existence of the corporation shall commence as of the time of the filing of these Articles of Incorporation with the Secretary of the State of Florida.

#### ARTICLE V PURPOSES

The general nature, objective and purposes of the Association are as follows:

1. To promote the recreation, health, safety and social welfare of the owners and residents of the Property referred to as *Pinecrest North Estates* in the Declaration;
2. To own, maintain, repair and insure the "Common Areas" as defined in the Declaration;
3. To operate without profit for the sole and exclusive benefit of its Members;
4. To perform all of the functions contemplated of the Association, and undertaken by the Board of Directors of the Association, in the Declaration.

**ARTICLE VI**




