ARTICLE V POWERS OF THE GRAND LODGE

Section 1 The Grand Lodge is a representative body and derives its just powers from the Blue Lodges which are its constituents and from immemorial uses usages and customs, and is therefore the Supreme Head of Ancient Craft Masonry in this jurisdiction.

Section 2 It has original jurisdiction over all subjects of legislation for the benefit of the Craft, and judicial powers in the interpretation of its own members; and appellate jurisdiction in all cases involving Masonic rights and benefits not in violation of the constitution and the established landmarks of the Craft; provided, that the Grand Master cannot be tried during his Grand Mastership, because there is none to preside in his absence. But when the term for which he was elected and installed has expired, he may be tried by the Grand Lodge if charges and specifications be filed against him within one (1) year after the expiration of his Grand Mastership, by not less than three (3) member lodges of the jurisdiction in good and regular standing.

Section 3 In case of an appeal from a suspension or an expulsion; the Grand Lodge acquits the accused or reverses the decision of the Lodge below, or when the Grand Lodge confirms the decision of the particular lodge, and subsequently restores the party to the rights and benefits of Masonry; the action of the Grand Lodge does not in either case restore the party to membership in the Lodge from which he is suspended or expelled, without the unanimous consent of the Lodge as in the case of a ballot for membership. In all cases of definite suspension, the member returns to his membership on the expiration of the term of his suspension.

Section 4 The Grand Lodge has the power to constitute new Lodges and to grant Charters and warrants under constitution for the same, and the supervision and approval of the By-Laws for their government provided their local regulations for the benefits of their Crafts be not interfered with.
