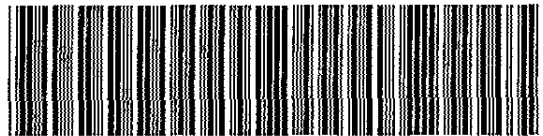

Articles of Incorporation of

**NGWA ASSOCIATION OF FLORIDA, Inc.,
a Florida Corporation**

The undersigned incorporator, for the purpose of forming a corporation pursuant to chapter 617, Florida Statutes, hereby adopts the following Articles of Incorporation:

Article I - Name

The name of the corporation shall be:

NGWA ASSOCIATION OF FLORIDA, Inc.

Article II - Principal Office

The principal place of business and mailing address of this corporation shall be:

Tallahassee, Florida 32303

Article III - Specific Purpose

The purpose of this corporation shall be:

1. To receive and maintain real or personal property, or both and subject to the restrictions and limitations hereinafter set forth, to use and apply the whole or part of the income wherefrom and the principal thereof exclusively for charitable, religious, scientific, literary, or educational purposes either directly or by contributions to organizations that qualify as exempt organization under Section 501 (c) (3) of the Internal Revenue Code and Regulations issued pursuant thereto as they now exist or as they may thereafter be amended.
2. To establish and maintain an environment and to provide a place for its members and the general public.
3. To solicit funds and donations in kind and from time to time further the purposes of this corporation.
4. To acquire and receive by purchase, donations or otherwise, any property, real, personal, or mixed, and to hold, use and dispose of the same.

5. To borrow money and to issue evidences of indebtedness in furtherance of any or all of the objects of its business; and to secure loans by mortgage, pledge, Deed of trust, or other lien.
6. To apply for, obtain and contract with any federal, state or local government or agency for a direct loan or loans or other financial aid in the form of grants or otherwise relating to the purpose of this corporation.
7. To engage in any kind of activity, and to enter into, perform and carry out contracts of any kind, necessary or in connection with, or incidental to the accomplishment of any one or more of the non-profit purposes of the corporation.
8. Notwithstanding any other provision of these Articles, the corporation shall not carry on any activities not permitted to be conducted or carried on by an organization exempt from taxation under Section 501 (c) (3) of the Internal Revenue Code and Regulations issued pursuant thereto as they now exist or as they may hereafter be amended, or by an organization, contributions to which are deductible under Section 170 (c) (2) of the Internal Revenue Code and said Regulations.
9. The corporation shall have such powers as are conferred upon it by Chapter 617 of the Laws of the State of Florida, and to exercise those powers in the accomplishment of its objectives and purposes. The By-Laws may impose other conditions of membership from time to time.
 - (i) To promote Social, Educational, Cultural and Economic Welfare of our Community.
 - (ii) To emphasize the common heritage of our people and to engage in activities aimed at encouraging the promotion of unity among our Community.




