We represent the clients of the above not-for-profit Corporation whose Articles of Incorporation were filed with you on September 2, 2003, using a principal address of 3000 Tamiami Trail South PMB #4, Venice, FL 34285, which was the business address of a self storage unit used by an officer of the above referenced non-profit corporation. That officer left that business and moved to Englewood, Florida and, apparently, mail addressed to the above corporation was never forwarded on to her. The current President said neither she, or the former officer, ever received their 2004 or 2005 Uniform Business Report notifications.
