ARTICLE I NAME.

The name of this non-profit corporation (501-c3) shall be FREE VENEZUELA, INC

ARTICLE II PURPOSE & DURATION

This corporation shall be NON-PROFIT 501-C3, and will strive to inform and educate the American Citizenry and Elected Officials about the Venezuelan and South American political climate.

- 1: No part of the Net Earnings of the Corporation shall inure to the benefit of or be distributable to its members, directors, officers, or other private persons except that this Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in this article.
- 2: No substantial part of the activities of this Corporation shall be carrying on of propaganda or otherwise attempting to influence legislation. This Corporation shall not participate or intervene in any political campaign on behalf of any candidate for public office, including the publishing or distribution of statement.

PERPETUAL EXISTENCE

This corporation shall have perpetual existence commencing on the date of filing of these articles with the Department of State of the Florida State.

DISSOLUTION

On the dissolution of this corporation, the Board of Directors shall dispose of all of the assets of this corporation exclusively for the purposes of this corporation in the manner of the organizations that are organized and operated exclusively for charitable, educational, religious or scientific purposes and that shall at the time qualify as exempt organization under §501 (C) (3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law, after paying or making provisions for the payment of all liabilities of this corporation. Any assets not so disposed of shall be disposed of by a court of competent jurisdiction in the county where the principal office of this corporation is then located exclusively for the purpose or to the organizations that the court determines are organized and operate exclusively for charitable, educational, religious or scientific purposes.
