## ARTICLES OF INCORPORATION

### ARTICLE I--NAME

The Name of the Corporation shall be Purge and Praise Temple of God, Incorporated.

### ARTICLE II--PRINCIPAL OFFICE

effective on  
9-1-03

The Corporation shall have a perpetual existence with the principal place of business address of 3506 Okeechobee Road, Ft. Pierce, Florida 34950, mailing address of the corporation at 104 Camelot Dr., Ft Pierce, Florida 34950.

### ARTICLE III--PURPOSES

The purpose of which this Corporation is formed, and the business and objectives to be carried out and promoted by it, are as follows:

1. This is a non- profit corporation.
2. To receive and maintain real or personal property, or both, and subject to the restrictions and limitations set forth in the By-Laws, to use and apply the whole or any part of the income therefrom and the principal thereof for the betterment of the Church, Community and Congregation.
3. To solicit funds and donations from time to time to further the purpose of this corporation.
4. To acquire and receive by purchase, donation or otherwise and property, real, personal or mixed, and to hold, use and dispose of the same.
5. To borrow money and to issue evidence of indebtedness in furtherance of any or all of the objectives of its business; and to secure loans by mortgage, pledge, deed of trust or other liens.
6. To apply for, obtain and contract with any federal, state local government or agency for a direct loan or loans or other financial aid in the form of grants or otherwise relating to the purposes of this corporation.
7. To engage in any kind of activity, and to enter into, perform, and carry out contracts of any kind, necessary or in connection with, or incidental to be the accomplishment of the purposes of this corporation.

#### ARTICLE IV---MANNER OF ELECTION OF DIRECTORS

The initial Board of Directors shall consist of three (3) members. They are to be elected by the members of the Purge and Praise Temple of God, Incorporated by a majority vote. The Directors are to be elected every four (4) years by the members of the Purge and Praise Temple of God, Incorporated.

#### ARTICLE V---INITIAL REGISTERED AGENT AND STREET ADDRESS

The initial Registered Agent of this corporation will be Jerry Lamar Gibson, whose mailing address 104 Camelot Dr., Ft Pierce, Florida 34950. Having been named as registered agent and to accept service of process for the above stated corporation at the place designated in this certificate, I hereby accept the appointment as registered agent and agree to act in this capacity. I further agree to comply with the provisions of all statutes relating to the proper and complete performance of my duties, and I am familiar with and accept the obligations of my position as registered agent.
