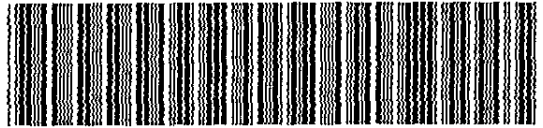

**ARTICLES OF INCORPORATION**  
**OF**  
**DARLINGTON COMMUNITY CENTER ASSOCIATION, INC.**

The undersigned, acting as incorporators of a corporation pursuant to Chapter 617, Florida Statutes, adopt the following Articles of Incorporation:

**ARTICLE I - NAME**

The name of the corporation is Darlington Community Center Association, Inc.

**ARTICLE II - DURATION**

The corporation shall exist perpetually.

**ARTICLE III - PRINCIPAL OFFICE AND MAILING ADDRESS**

The address of the principal office of the corporation shall be 36 Escambia Street, Westville, Florida 32464, and the mailing address of the corporation shall be 36 Escambia Street, Westville, Florida 32464.

**ARTICLE IV - PURPOSE OF THE CORPORATION**

The purpose of the corporation shall be to accept title to the present Darlington school facility from the Walton County School Board, to operate and maintain said facility and to promote the proper use of the property.

In the event that an outside organization submits a request to use the facilities, the Board of Trustees will determine if the request meets with the purpose of the Darlington Community Center. When the event is approved, the Board of Trustees will establish a Facility Use Fee for the activity.

#### ARTICLE V - MEMBERSHIP

The members of the corporation shall be determined as provided in the By-Laws.

#### ARTICLE VI - INITIAL REGISTERED OFFICE AND REGISTERED AGENT

The initial registered office shall be at 1901 State Hwy. 2 East, DeFuniak Springs, Florida 32433, and the initial registered agent shall be Terry Smith.

#### ARTICLE VII - INITIAL BOARD OF DIRECTORS

This corporation shall have three (3) Directors initially. The number of Directors may be changed by amendment of the By-Laws, but shall never be less than three (3). The names and addresses of the Directors of this corporation until the election of their successors as provided in the By-Laws are:




