ARTICLES OF AMENDMENT NOT FOR PROFIT ARTICLES OF INCORPORATION SUMMER POINTE HOMEOWNERS ASSOCIATION, INC.

Pursuant to the provisions of Section 617.1006, Florida Statutes, the undersigned Florida Not for Profit Corporation adopts the following articles of amendment to its articles of incorporation:

First: Amendments adopted:

ARTICLE III

PURPOSE

The purpose for which the corporation is organized is to own common areas in Steinhatchee Village and administer and enforce covenants and restrictions on individual homeowners as a part of a homeowners association.

The Association shall operate, maintain, and manage the Surface Water or Storm Water Management System(s) in a manner consistent with Suwannee River Water Management District ("District") permit and applicable District rules, and shall assist in the enforcement of the Declaration of Covenants and Restrictions which related to the Surface Water or Storm Water Management System(s).

ARTICLE VIII.

BY-LAWS AND AMENDMENT OF ARTICLES

The By-Laws and Articles of Incorporation will be adopted and may be amended by the Directors or members, consistent with these Articles and the declaration.

Should a conflict exist or arise between any of the provisions of the Articles of
