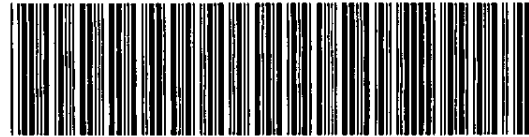

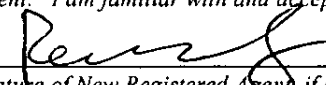

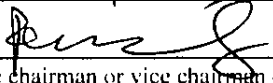

**ARTICLES OF INCORPORATION
OF
HUA-GEN CHINESE SCHOOL, INC.
AS AMENDED**

In compliance with the requirements of F.S. Chapter 617, the undersigned hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of Organizing a NOT FOR PROFIT corporation.

**ARTICLE I
NAME**

The name of this corporation is:
HUA-GEN CHINESE SCHOOL, INC.

**ARTICLE II
PRINCIPAL OFFICE**

The street address of the principal place of business of the corporation is 8559 SW 11th Road, Gainesville, FL 32607.

**ARTICLE III
PURPOSE AND DISSOLUTION**

PURPOSE: The purpose of this not for profit corporation is to provide a school environment, including classroom teaching, for K-12 students and to learn Chinese language and Chinese culture. **HUA-GEN CHINESE SCHOOL, INC.** is organized exclusively for these purposes under section 501(c)(3) of the Internal Revenue Code.

DISSOLUTION: Upon the dissolution of **HUA-GEN CHINESE SCHOOL, INC.**, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.

**ARTICLE IV
MANNER OF ELECTION**

The manner in which the directors are elected is as follows:
The number of directors to constitute the board of directors shall be five.

The directors are elected in the annual meeting by the parents of the students. A simple majority of the votes by the meeting attendees is needed.

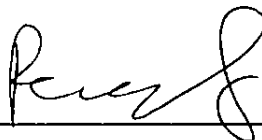
