Articles of Incorporation of IAC – International Academy of Conscientiology, Inc.

Preamble

The IAC – International Academy of Conscientiology, Inc. is a scientific, educational, cultural, apolitical, and universalistic not-for-profit corporation governed by these Articles of Incorporation.

Article I—Name

The name of this not-for-profit corporation is *IAC - International Academy of Conscientiology*, *Inc.*

Article II—Address

The address for the corporation is 7800 SW 57th Avenue, Suite 207-D, Miami, Florida 33143.

Article III—Purposes

- 1) The purposes that the corporation will pursue in this State and the activities that it proposes to conduct in this State are as follows:
 - a) General Purposes and Activities
 - i) The IAC aims to catalyze the global evolution of human beings through promoting an ever-increasing understanding about the nature of the consciousness (individual essence) and its multidimensional reality.
 - ii) The most essential end of the work of IAC is to provide high quality assistance to individuals by clarifying about the multidimensional nature of consciousness and laying the groundwork for the maximum development of their human potential. Understanding the scope of the manifestation of consciousness allows individuals to obtain a more productive perspective on life, thus becoming better able to cope with strenuous circumstances and execute their life purpose with more determination and clarity. This objective is accomplished by IAC's constant care to disseminate leading-edge knowledge through its wide range of educational activities and scientific publications.
 - iii) Driven by the recognition of the importance of supporting the evolution of consciousness while respecting the expression of individual free will, the IAC's work is directed to increasing integrated maturity, at a physical, emotional, parapsychic, and intellectual level.
 - b) Specific Purposes and Activities Research
 - i) To study the consciousness in its entirety, researching its manifestations from an all-inclusive standpoint (both inside and outside the body), deepening our

- understanding of human life and providing a substantially richer context for understanding existence.
- ii) To advance the science of conscientiology, acting as a focal point for the global development of consciousness research, new research techniques, and the application of that research and those techniques in efforts to foster scientific understanding of the consciousness.
- iii) To catalyze the natural progression of accepted scientific endeavor to support currently excluded but vital areas of study, integrating conscientiology into contemporary science.
- iv) To sponsor scientific debate around a range of subjects related to consciousness research through forums, public meetings, congresses, and journals and other scientific publications.
- c) Specific Purposes and Activities Education and Dissemination
 - i) To disseminate vital information regarding the nature of consciousness, using methods and techniques that allow individuals to verify presented concepts and ideas through personal, individual experience.
 - ii) To promote the development of multidimensional self-awareness.
 - iii) To provide access for all interested individuals to conscientiology's core ideas and experiments through the establishment of public services on the Internet as well as specialized libraries and media centers worldwide.
 - iv) To develop new and existing courses, constantly updating techniques and content based on its leading-edge research findings.
 - v) To consistently acknowledge the essential value of personal, experiential verification of new ideas, applying the credo "Don't believe in anything. Not even what you hear at the IAC. Have your own experiences."
- 2) Whenever possible and advisable, the corporation will engage in technical, scientific and cultural exchange with other similar institutions in the United States of America and internationally.
- 3) The corporation is organized exclusively for scientific and educational purposes, including, for such purposes, the making of distributions to organizations within the meaning of Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.
- 4) No part of the net earnings for the corporation will inure to the benefit of, or be distributable to, its members, trustees, officers or other private persons, except that the corporation will be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth above. No substantial part of the activities of the corporation will be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation will not participate in, or intervene in any political campaign on behalf of or in opposition to any candidate for public office.

- 5) Notwithstanding any other provision of these articles, the corporation will not carry on any other activities not permitted to be carried on:
 - a) By a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code, or the corresponding section by any future federal tax code; or
 - b) By a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Article IV—Elections

The manner in which directors are elected and dismissed is stated in the bylaws of the corporation.

Article V-Directors

The Board of Directors is as follows:

Article VI—Registered Agent

The Registered Agent for the corporation is Patricia Sousa, with address at 7800 SW 57th Avenue, Suite 207-D, Miami, Florida 33143.

Article VII—Incorporator

The Incorporator for the corporation is Rodrigo Medeiros, residing at 8107 SW 72nd Avenue, Apartment 307-E, Miami, Florida 33143.

Article VIII—Non-Membership Corporation

The corporation is not a membership corporation, although it may have nominal members who do not possess voting rights.

Article IX-No Guarantees

Under no circumstances may the corporation act as guarantor to organizations, to third parties, or to members of the Board of Directors.

Article X—Dissolution

The corporation may only be dissolved if and when it becomes completely impossible to fulfill its corporate purposes on general terms. Such a decision must be made by the Board of Directors at an Extraordinary Meeting specially called for that purpose. The corporation's assets must then be donated in full to institutions related to projectiology and conscientiology, with educational and scientific purposes similar to those in Article III above, within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.
